- **FOOD VENDORS ARE RESPONSIBLE FOR OBTAINING THE NECESSARY NASSAU COUNTY BOARD OF HEALTH PERMIT FOR DISPENSING FOOD. YOU SHOULD HAVE THE PERMIT IN YOUR POSSESSION AT ALL TIMES AS THERE WILL BE A BOARD OF HEALTH INSPECTORS ON SITE THAT DAY. COLUMBUS LODGE ASSUMES NO RESPONSIBILITY IN THIS MATTER.**
- **ALL VENDORS MUST REMOVE THEIR VEHICLES FROM BROADWAY BY 10:00 AM AND CLOSE UP AT THE END OF THE DAY WHEN REQUESTED TO DO SO. (Start closing at Approximately 5:40 P.M.) AS STREETS NEED TO BE CLEANED FOR THE EVENING.**
- **AT THE TIME OF APPLICATION AND PAYMENT, ALL FOOD, GAMES, AND RIDE VENDORS MUST FURNISH A CERTIFICATE OF INSURANCE NAMING COLUMBUS HOME LODGE AS AN ADDITIONAL INSURED.**
- **NO VENDOR WILL BE ASSIGNED A SPACE WITHOUT HAVING MADE PAYMENT IN ADVANCE. HOWEVER, ON THE MORNING OF THE FEAST THERE WILL ALWAYS BE SPACES AVAILABLE. A BOOTH WILL BE IN FRONT OF THE DAIRY BARN STORE (N. CEDAR STREET AND BROADWAY) AT 8:00 A.M. CASH ONLY AND THERE WILL BE A \$25.00 SURCHARGE PAYABLE THAT DAY.**
- **TO AVOID CONFLICTS, WE TRY TO SEPARATE VENDORS WITH SIMILAR ITEMS FOR SALE. THEREFORE, SELL ONLY THE MERCHANDISE LISTED ON THE REVERSE SIDE. YOU WILL BE STOPPED FROM SELLING ANY OTHER ITEMS AT THE FESTIVAL, THAT CONFLICT WITH OTHER VENDORS WHO ARE NOT COMPETING WITH AND SELLING LIKE ITEMS OF YOURS.**
